Through its network of volunteer attorneys and financial professionals, LINC provides advocacy services for cancer patients related to insurance coverage for medical care costs, employment, securing disability benefits, arranging for care and custody of children, forestalling debt collection efforts, and planning for the future by

LINC also conducted meetings and seminars for numerous attendees at various locations to publicize its services to the public.
